Objective: This portfolio invests in a blend of Equities which account for around 60% of the portfolio by weight. The remainder of the portfolio is held in Fixed Interest and a balance in other assets. The portfolio strategy has been designed to blend Passively Managed funds and a smaller number of selected actively managed funds, aiming to generate capital growth over the longer term.

Target Market: This portfolio is suitable for investors with a time horizon of 5 years or more who are willing to accept Medium levels of investment risk in return for the potential for participation in rising investment markets. This fund is designed for investors who can afford more than a modest loss of their investment.

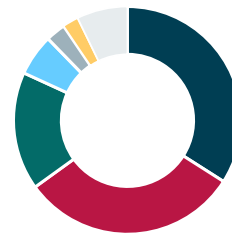

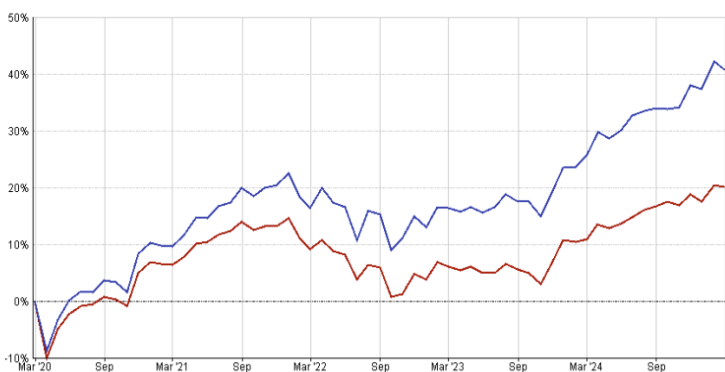
